Larkfleet urges government to extend support for construction

The Chairman of the Larkfleet Group of Companies is supporting the Home Builders Federation (HBF) in its calls for the government to do more to help housebuilders through the coronavirus crisis.

HBF is in constant dialogue with ministers, discussing matters such as how its members can access recently announced financial schemes and the need for existing planning permissions to be extended by 12 months.

Stewart Baseley, HBF's Executive Chairman, wrote to Housing Secretary Robert Jenrick to set out HBF's wishes on various matters including planning consents and Section 106 payment deferrals.

Looking ahead to a post-Covid recovery, the HBF said: "Housebuilding can play a key part in helping the UK's long-term recovery by generating benefits throughout the economy. The housing market may take some time to recover from this shock but, in the long term we want to avoid a major impact on our efforts to address the country's housing shortage."

Larkfleet Chairman Karl Hick said the government must "play its part" in aiding the industry's return to economic activity.

He added: "The chancellor is only too aware that the construction industry is a big contributor to the UK economy. In 2018, the construction sector (commercial and housing combined) contributed £117 billion to the UK economy.

"Events of the past few weeks have clearly shown that humanity is not 'in charge' of its own destiny. But as we work our way through the crisis, we must get back to normal economic activity as swiftly as possible.

Larkfleet CEO warns funding issues and skills gap could derail government's housing targets

Industry and government need to tackle the skills gap in construction and unlock funding constraints if plans to speed up home building are to be effective.

The government has published the most radical overhaul of the English planning system in a generation, in a move to accelerate the delivery of urgently needed new homes. Housing Minister Robert Jenrick said reforms in the Planning for the Future white paper would produce high quality, sustainable homes on land labelled for growth, renewal or protection.

Housing ministers claimed the planning overhaul is intended to help SME housebuilders, with plans to make the

John Anderson Larkfleet CEO housing industry "more diverse and competitive to drive delivery and higher standards".

Larkfleet CEO John Anderson said: "These proposals are certainly a positive step forward and they underpin how serious the government is about tackling the barriers that are holding back the housing market.

"The reforms may also provide a boost for SME housebuilders, but there remains the huge hurdle of funding for the SME market which must be addressed. The government and Homes England are making all the right noises, but we need to encourage lenders to increase the

availability of higher LTC (loan to cost ratio) debt – perhaps by introducing government-backed indemnities for lenders."

Mr Anderson also raised concerns about the continuing skills gap housebuilders are facing. He said: "If we are to accelerate housing delivery, we must also have a solution for the severe shortage of skilled construction workers to meet the government's housing target. The new immigration policy will inevitably restrict the skills needed to supplement our homegrown skills, so we need to invest in education and training for both technical and non-technical construction skills.

"I welcome many aspects of the proposals, especially the presumption for development in designated growth areas, the simplification of Local Plans and the speeding up of the decision making process.

"These reforms are long overdue. We urgently need a planning system that is agile, transparent and fit for purpose for present and future generations.

"However, it will be impossible for SME housebuilders to increase their development schedules without a serious review of how new projects can be funded and how they can be built given the acute shortage of construction workers."

The consultation on the housing ministry's wide-ranging measures closes on October 29.



Politicians and business leaders plan a way forward for housebuilders following Covid-19

Politicians and business leaders plan a way forward for housebuilders following Covid-19

More than 70 business leaders and construction industry professionals, from across the Midlands and East of England, met at a virtual conference to discuss the future of housebuilding in the wake of Covid-19.

The event – titled **'Covid-19 – meeting the challenges of housebuilding recovery'** – was hosted by The Larkfleet Group of Companies, which includes housebuilders Larkfleet Homes and Allison Homes.

Speakers at the event – now in its fifth year – included Larkfleet Group Chairman **Karl Hick**, **Andrew Lewer** MBE, MP for Northampton South, **Ben Rudd**, Associate Director, Development, at Savills, and **Kelham Cooke**, the Leader of South Kesteven District Council.

The conference, held on 22 July, attracted delegates from the public and private housing sectors, including planners, estate agents, surveyors, builders and developers.

In a series of presentations and discussion sessions, the conference examined the recovery challenges facing the housebuilding industry. Topics discussed included the proposed changes to the planning system, how district councils can assist with the delivery of housing targets and the state of the land market.

Karl Hick opened by raising several important issues. He said: "The government has been clear that recovery in the construction industry is fundamental in terms of boosting the economy, providing jobs and delivering new homes.

"We welcome the Business and Planning Bill, including measures to extend planning permission deadlines so that projects put on hold because of Covid-19 can still be delivered, as well as the new flexible working hours on construction sites to enable us to get our teams back to work safely. "However, we need to work together to urge the government to extend the Help to Buy scheme. It would be fair to say 80 per

cent of sales relate to HTB, so sales would drop to 20 per cent without it. This would be disastrous for the housebuilding industry, the economy and people desperate to buy a new home – and would derail the government's recovery plans.

"The government also needs to help SME builders to deliver the energy-saving initiatives set out in the Future Homes Standard to reduce carbon emissions from new buildings. This is a tricky one for me. Larkfleet Homes is probably the most sustainable builder in the UK, but we struggle to deliver some of the environmental initiatives because sale values would not cover the additional costs. It is a complicated issue as housebuilders in some areas of the UK will be able to afford it, because of land and house values."

Andrew Lewer also chairs the All-Party Parliamentary Group for SME House Builders, which was set up to look at the issues home builders are facing, via the planning process, in delivering the government's target of 300,000 new houses a year. It aims to provide answers to parliament and government on how England can provide more and better new homes, primarily through SME builders and developers.

He said: "Lobbying by the big builders is focused on them, so SME housebuilders need their own voice. We have nearly 200 participants from all over the country coming to parliamentary meetings, so we are gathering a body of evidence from the people who are actually involved in delivering housing.

"We have just published a report on ways to improve the planning system in the UK, and this will be put to ministers in terms of detailed recommendations."





an increase of nearly 25% of homes in our district. Clearly this is an immense challenge, but it is one I am determined to meet.

"However, we can't do this alone. As a partner, we bring to the table the ability to create the right environment within which you can thrive and prosper. You bring to the table your considerable skills, knowledge, and expertise to turn the opportunity we create into reality."

Ben Rudd from Savills said that postlockdown "many housebuilders have been trying to do land sales with a 'Covid clause', allowing them to terminate if conditions worsen during the buying stage.

"Most builders have restarted construction, though generally at a slower pace because of Covid restrictions. This will slow the pace of delivery of homes to the market but could protect prices."

Sam Hart, Director of Sales at Larkfleet Homes, said: "The market has held up and we've seen a bounce-back in inquiries and reservations. Whether this will continue, we will have to see. We need Help to Buy to be extended. This initiative is not just about first-time buyers, but second-timers too. Help to Buy will be the key driver to keep the market stable so that we can continue delivering homes for all."

Karl Hick concluded the conference by referencing further challenges facing the housebuilding industry.

He said: "I think one of the issues, as we come into Brexit is that some reports said it would cost up to £200 billion to manage the divorce and that would have been possible with the funding we had pre-Covid. But now that we have a massive shortfall as a result of coronavirus, does the government borrow another £200 billion? What will be the repercussions of the Chinese dispute for the UK economy? Combined with coronavirus, these factors mean we have a perfect storm coming and it is a big concern."

He added that national, globallyacclaimed projects such as HS2 and the expansion of Heathrow airport are "massively important to keep UK PLC stable internally and open for business externally".

Larkfleet welcomes campaign for affordable homes

The National Housing Federation launched its Homes at the Heart campaign in early July, urging the government to put social housing at the centre of its economic recovery plan.

The campaign is supported by more than 60 housing groups, charities, banks and thinktanks. They argue that the coronavirus pandemic and subsequent lockdown has underlined the need for high quality, well-designed and affordable homes. This will be a major driver of economic recovery as every pound spent by the government on building new social homes generates at least £5 in local economies across the country, the federation said. The NHF has suggested that the government earmarks "up to £3bn of the

recently announced £12.2bn affordable homes budget to support the short-term recovery". This would be used to fund additional flexibilities in the current grant programmes and extend the existing Shared Ownership and Affordable Homes Programme for an additional year to 2022, with the same conditions as the current programme, the federation added.

Karl Hick, said: "We warmly welcome the NHF's latest campaign. The housebuilding industry drives not only economic growth, but also provides much-needed housing to support sustainable communities.

"The provision of shared ownership and affordable homes is a crucial part of the industry as these tenures account for

> a significant proportion of new-build sales – to housing associations and private buyers.

"It is also critical for the housebuilding industry that the government extends its Help to Buy initiative, which lends purchasers up to 20 per cent of the cost of a newly built home – with as little as a 5 per cent deposit. This initiative has helped hundreds of thousands of people to buy well designed, good quality new-builds such as those built by Larkfleet Homes.

"The existing HTB scheme will be restricted to first-time buyers from April 2021 and includes regional property price caps that will weaken its effectiveness, given the severe economic conditions.

"Around 80 per cent of present sales relate to HTB, so if Help to Buy is phased out, as is currently planned, the market for newly built homes will fall off a cliff, housebuilders will go bust, and thousands of jobs will be lost. This would spell disaster for both the national and local economies, exacerbate the housing crisis and see communities fall apart.

"It is important to remember that the health of the housebuilding market is directly linked to the delivery of affordable homes. If sales fall away and housebuilders can't afford to bring developments to the market – which include allocations for affordable homes – then opportunities for building this much-needed housing will be scarce. If sites can't be started, then the government will have nowhere to spend its affordable housing budget, and its targets won't be met.

"We must do everything we can to avert this looming disaster, both for the market and social housing delivery."
